## Why a Cross-border Deal?

► Over the past 20 years, we've been living in an increasingly uncertain world, where crisis follows crisis, whether economic, environmental, health, democratic or even military. What if we dared to talk about the **future** and ask ourselves what our cross-border territories will look like in 2050?

► Because our **resources** and common goods are becoming increasingly scarce and require us to go beyond our mental and administrative borders, and because they themselves have no borders, what if we dared to manage, preserve, and develop them on the scale of cross-border areas? What if we dared to imagine a differentiated model?

► As we Europeans gradually begin to add the term «European» to economic, energy and agricultural sovereignty, and at a time when the **sovereignty** of a European state is being threatened to the east of our continent, what if we dared to speak of «cross-border

sovereignty» to meet the needs of our current and future populations?

► Because the European promise has always been not only peace between peoples, but also economic and social prosperity, and territorial cohesion, what if we dared to really give ourselves the means of a cross-border cohesion policy? And what if, beyond convergence and solidarity, we gave ourselves the means for genuine cross-border **co-development**?

► Because **citizenship** represents a bond of belonging, a political bond as well as a historical and cultural bond, what if we dared to speak of «cross-border citizenship» by promoting our common cultures and histories through education, or by enabling the expression of a cross-border democracy in which citizens would have the right to participate?

Because over the decades, we have gone from a state of «faith» in Europe to a state of «doubt», even though Europe is the solution; because at a time of major transitions, resilience must prevail over resignation; and because the everyday Europe and the feeling of belonging to Europe are played out first and foremost at its internal borders, **what if we dared to make a societal, democratic and citizen-centric «cross-border deal»?**



## Main organiser

**The Mission Opérationnelle Transfrontalière (MOT)** is the result of a long-term partnership on French borders between cross-border territories and national and European levels. Alongside its members, partners, and European networks, it plays an active role in cross-border policies at all three of these levels.

## Objectives of the 3rd Borders Forum:

**1. Call on French and European political leaders** to open the debate on a «cross-border deal» for territories that concern 40% of Europe and 2 million cross-border workers (including 500,000 in France).

**2. Debate the issues of solidarity, sovereignty and reciprocity with two days of exchanges on borders**, a topic that marked the 2024 media landscape.

**3. Put forward proposals for resolving cross-border obstacles** by tackling very concrete issues that impact the daily lives of residents during **10 technical workshops**.

Cross-border territories are home to **30% of Europe's population**. Two million European workers are cross-border workers.

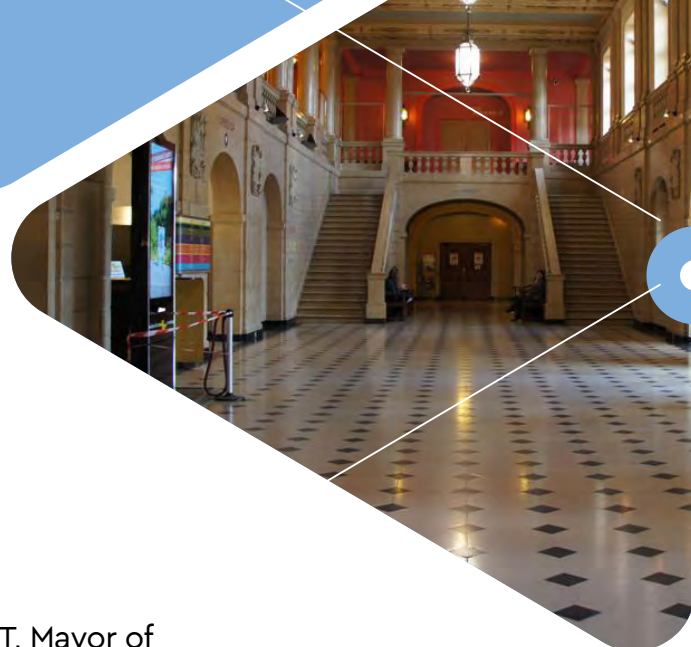

No «deal» without the trust of the people. But will a cross-border demos exist in 2050?

In the second half of the 20th century, Europe represented a hope, a promise, sometimes even an ideal for the peoples of Europe and far beyond. Over the past quarter-century, however, this ideal has been undermined, culminating in the rise of Euroscepticism in the most recent European elections. The EU's desire to unite not only states, but also peoples, in all their diversity, is particularly evident at borders, where nationals of different countries come face to face and share daily realities. The sense of belonging, whether to one's own country, region or Europe, is often manifold. On the inner borders of Europe, is it possible to experience a shared identity, a cross-border sense of belonging? In these hybrid yet innovative territories, the question of «cross-border citizenship» is not off the table. This round-table discussion will dare to debate this notion, which is far from a consensus, and discuss belonging beyond borders.

In a world marked by multiple crises and growing interdependence, solidarity takes on a new dimension in a cross-border context. In the face of economic, environmental, health, democratic and military threats, the notion of «European sovereignty» is gaining ground, but is also showing its limits. Managing today's challenges requires us to go beyond our mental and administrative boundaries, and consider solutions on the scale of cross-border areas... but are we ready to talk about «cross-border sovereignty» to meet the needs of our current and future populations?

The European promise of peace and prosperity today calls for greater cohesion and a move beyond national boundaries towards genuine cross-border co-development. This round table explores these concepts to imagine a future where sovereignty and solidarity are reinvented beyond borders.

## « Ecological planning in cross-border living areas »

## « Cross-border financial solidarity: Global workshop »

## THE EUROPEAN COMMISSION

For the 2021-2027 period, it proposes that funding for territorial cooperation (Interreg) should pay greater attention to these territories in order to stimulate recovery in border areas, where economies have often been particularly disrupted by the health crisis. Through its «Border Focal Point», the Commission places cross-border issues at the heart of its priorities. The MOT maintains close links with DG Regional and Urban Policy (REGIO), the department in charge of EU regional policy, while its network regularly contributes to the European Commission's consultations, to help ensure that cross-border territories are taken into account in EU policies.

and International Development. In the field of decentralized cooperation, the DCTCIV defines and implements the Ministry's support strategy (calls for projects, joint schemes, program to promote territorial expertise, etc.), complementing the actions of all partners.

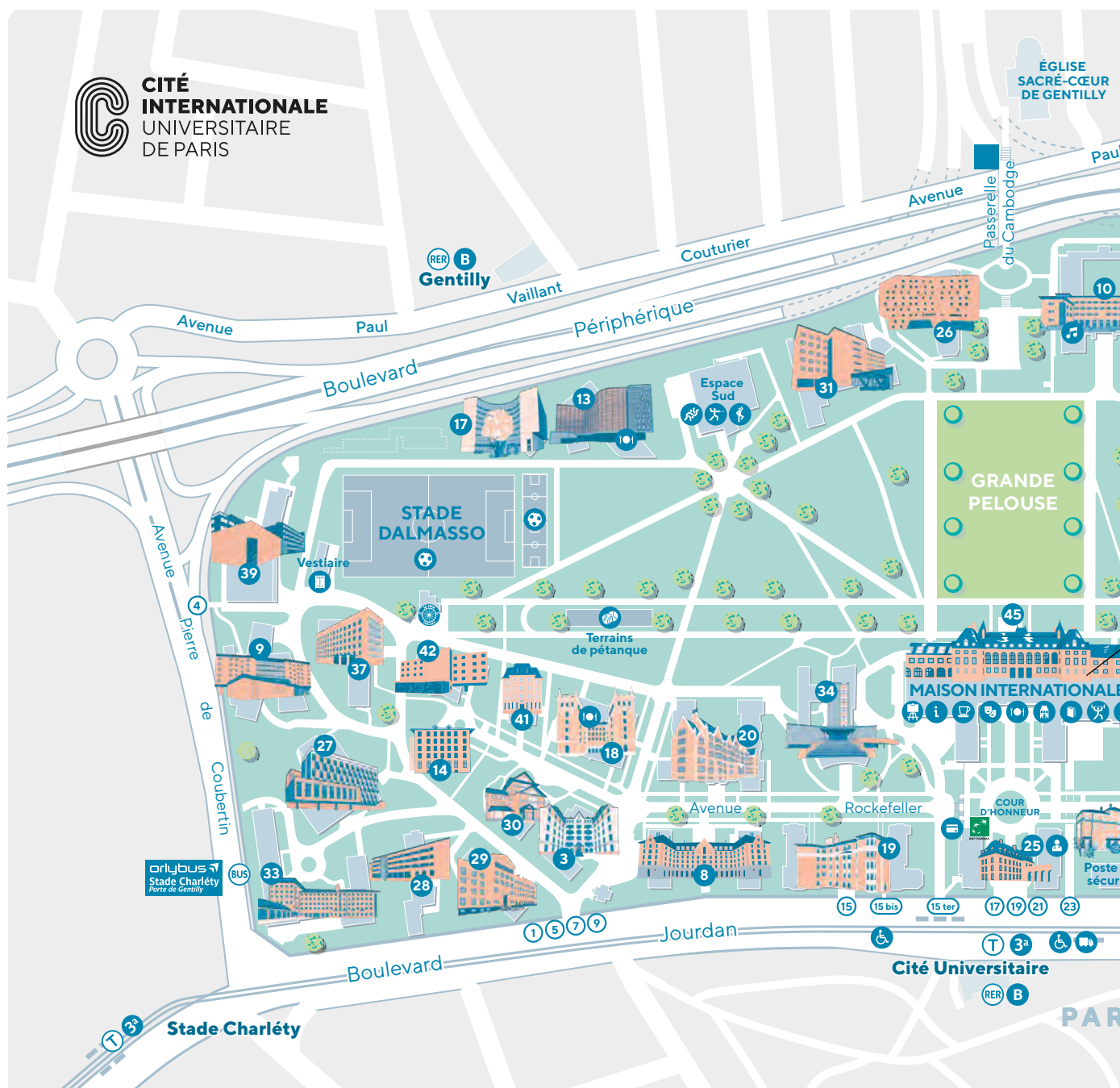

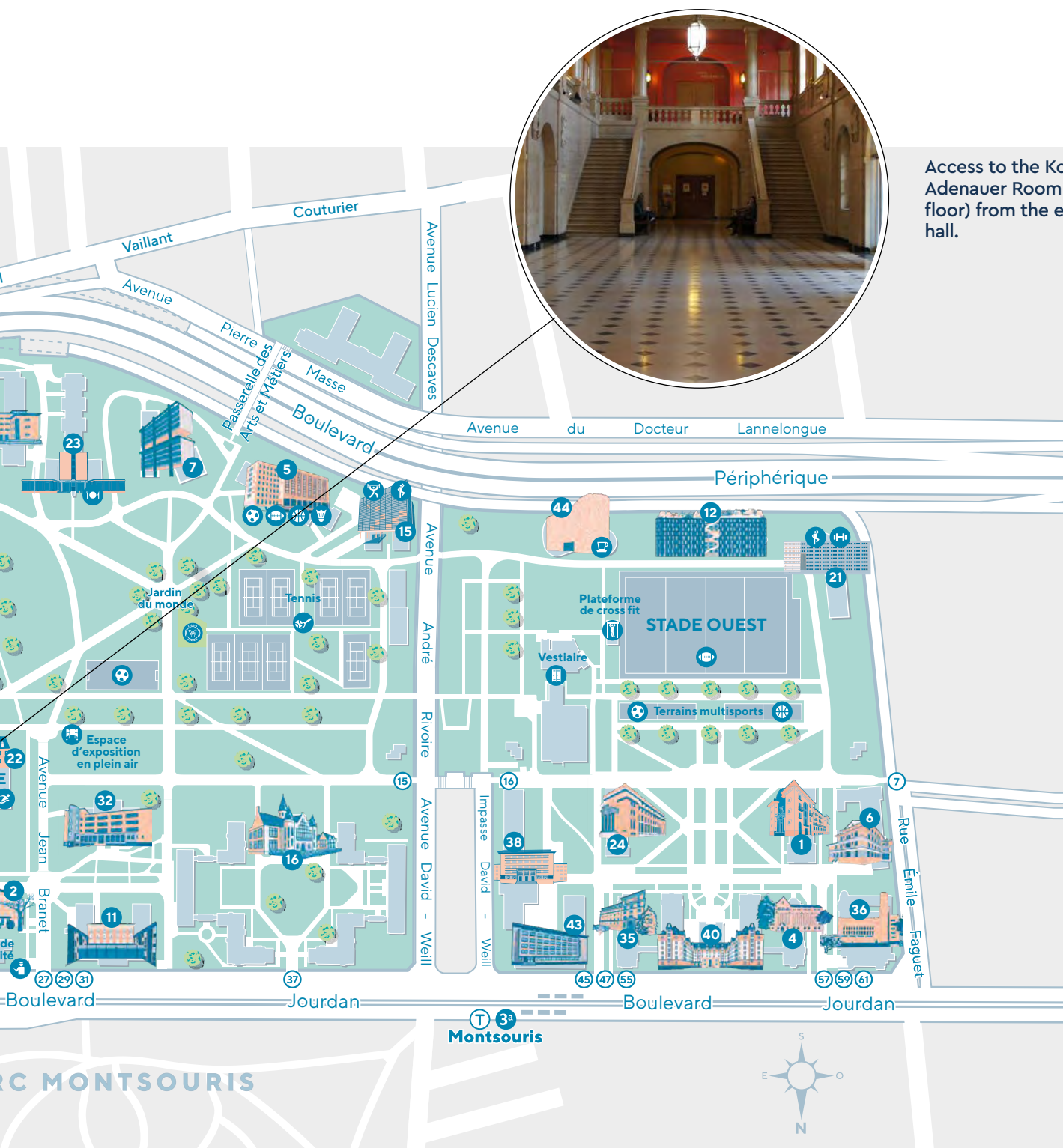

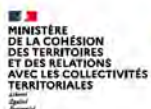
